Rep. Erika Uyterhoeven to Chair the United World Leaders Council on the Integrity of Governance in the Age of AI

Erika Uyterhoeven as Chairwoman of the newly established UWL Council on the Integrity of Governance in the Age of AI.



Erika Uyterhoeven currently serves as a Massachusetts State Representative and is a former antitrust economist trained at the University of Toulouse. She is the author of comprehensive state-level AI governance integrity legislation currently in development. Candidate for Massachusetts State Senate, 2nd Middlesex District (Somerville, Medford, Cambridge, and Winchester).

The launch of the UWL Council on the Integrity of Governance in the Age of AI comes at a critical moment as governments across every continent rapidly integrate AI technologies into governing processes without corresponding oversight structures, governance safeguards, or internationally coordinated frameworks. The Council will focus specifically on the protection of governing systems from the distortions, vulnerabilities, and unintended consequences

introduced by emerging AI technologies.



The Initiative is designed to address a growing global governance gap. Recent years have already seen AI-generated election interference, deepfake disinformation campaigns, AI-driven surveillance deployments, opaque procurement arrangements, and automated administrative systems affecting populations at national scale without meaningful public review or legislative oversight.

As a Chair of the Council, Rep. Erika Uytterhoeven will be responsible for identifying and engaging with the Institution leading government officials, legislators, policymakers, AI and technology leaders, cybersecurity and digital infrastructure experts, election and public administration authorities, academic and research institutions, constitutional and legal scholars, international organizations, humanitarian and civil society leaders, media integrity and disinformation experts, as well as major business, financial, and investment stakeholders from across regions and governing systems worldwide for the purpose of advancing the mission of the Council and strengthening the integrity, resilience, and responsible governance of public institutions in the age of artificial intelligence.

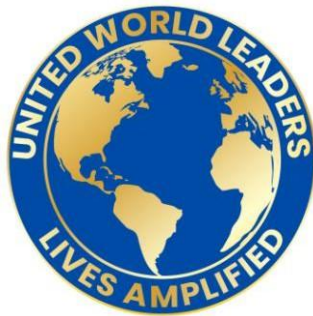
Under the leadership of Erika Uytterhoeven, the Council will focus on:

- Developing and sharing model legislation for AI in government — specifically protecting the integrity of procurement, elections, public administration, and legislative processes.
- Building a body of knowledge from real cases where AI intersected with governing processes, including procurement failures, election manipulation, surveillance deployments, and administrative decision-making.
- Creating the peer network for government leaders navigating these challenges across borders and governing systems.

Planned Council initiatives include:

- The Legislative Exchange — an annual working session where legislators and government officials from different nations and governing systems share model legislation, implementation results, and failures related to AI in government.
- “Perspectives on Governance in the Age of AI” — a monthly virtual dialogue featuring a government official, a technologist, and a civil society voice from three different countries discussing a specific governance integrity challenge.
- “State of AI in Governance” Report — an annual assessment of how AI is affecting governing processes worldwide, covering procurement, elections, public administration, legislative processes, and surveillance.

The Council shall remain non-political and non-adversarial in nature, focusing exclusively on humanitarian initiatives, governance integrity, and the protection of governing processes worldwide.
